Pursuant to the scrip dividend scheme of ISDN Holdings Limited ("Company"), 790,173 ordinary shares in the capital of the Company had been issued and allotted to NTCP. Accordingly, NTCP holds 36,311,574 ordinary shares (the "ISDN Shares") in the capital of the Company.

Novo Tellus PE Fund 2, L.P. ("NT Fund 2") is the owner of 100% of the shares of NTCP and is therefore deemed interested in the ISDN Shares held by NTCP.

New Earth Group 2 Ltd ("NEG 2") is the general partner of NT Fund 2. Accordingly, NEG 2 has deemed interests in the ISDN Shares held by NTCP, which NT Fund 2 is deemed interested in.

Keith Hsiang-Wen Toh ("Keith Toh") is entitled to exercise or control the exercise of not less than 20% of the votes attached to the voting shares in NEG 2. Accordingly, Keith Toh has deemed interests in the ISDN Shares held by NTCP, which NT Fund 2 and NEG 2 are deemed interested in.
